

General Membership Meeting: October 10, 2017

**Called to order** by Vice President Melinda Balint at 6:38 pm at Black Bear Diner in Davis, CA

Corrections to minutes of September 2017 meeting: Need verification on taxes and the trailer pad needs to be 10' x 30.' The minutes were then MSP as corrected.

### Officers' reports

President: absent

Vice President: VP Melinda Balint thanked everyone for coming.

<u>Secretary</u> (Cherrrie Brown): Received copies of notices from AKC approving December 2017 scent work trials and May 2018 Obedience and Rally trials.

<u>Treasurer</u> (Louise Wilson): We have a balance of \$9481.00. The trailer license arrived. The bank is charging \$45.00/month fee on our account. Louise has a list of the agility equipment sold for a total of \$4185.00. AOCNC lost our check and another has been sent to replace it. We have paid \$200 to West Plainfield Station to reserve scent work trial site. It was MSP that we acknowledge receiving the audit report.

### **Committee Reports**

<u>AOCNC</u> (Tiffany Stutzke): The meeting is the Saturday following this meeting. Melody Tate and Tiffany will attend. The latter will have a report.

6:45 – 7:15 pm: The meeting was suspended while food was served.

CGC (Tiffany): Tests are being given for specialty clubs.

We had discussed having training for juniors to better prepare them for the CGC test. AKC is pushing for pee wee trials. Louise commented that CGC evaluators can test the new trick dog test. Tiffany questioned whether there is cross over for the farm dog test.

<u>Hearts and Flowers</u> (Tiffany) A card was sent to Mary Lou Just for the death of Don Just. She also acknowledged the memorial for Stephanie Cross, a DDTC member who recently passed. Tiffany will stay Hearts and flowers chair for now but would like to be replaced.

<u>Nose Work:</u> Scent Work trial secretary Valerie Gulyash reported that we currently have 34 entries in the December trials with most entered in all four trials. Everything is on track. Pending AKC approval the next trial will be February 17, 2018, will probably have all elements (search environments) and will be one day, one trial.



2018 Obedience and Rally Trials: Tiffany reported that all judges are confirmed. Valerie will reserve the site as soon as Dixon will accept applications (December). We will offer Beginning novice A and B as well as the regular classes. Linda Hause will judge utility A and B, novice A and both beginner novice classes. Pat Beauchamp will judge open A and B, and novice B. Alvin Ing will judge all rally classes from novice to masters. Pam Jewell said we have lots of rosette centers on hand as well as some trophies. She will take an inventory to determine what we need for the trial. There will be a cash prize for high in trial and high combined in open B and Utility. There are some left over breed and group trophies. We will not offer group trophies in 2018. There are a couple of non-specific breed trophies that were donated.

<u>Philanthropic:</u> It was suggested that we donate to a relief fund for animals displaced but the Northern California wildfires as well as our usual donation to the VMTH scholarship in memory of Jane and Don Norton. It was moved (Louise) and seconded (Leslie Earl) to make these donations. Kathy Souza will check out a fireman's fund for animals she heard about.

Ring Ropes: Melinda said "good job" in reference to Bridget Curry's work on the newsletter.

<u>Tracking:</u> We need to keep our date but Tiffany has not found a new site for TD or TDX. She suggests that we have a TDU (tracking dog urban) test to keep the date. She is working on a site in Elk Grove.

<u>Training:</u> Somewhere we have a document saying that training is a requirement for the club. Bridget moved to set up a committee to investigate this. Tiffany Stutzke and Tonya Berger will be on the committee.

Nomination Committee: A treasurer and VP are still needed for the slate. Melody Tate will run for President, Cherrie agreed to stay on as secretary. Regarding the treasurer job, it was suggested by Tiffany that the treasurer have an assistant. Leslie suggested having a CPA do the taxes. We also need 5 directors. Pam will not continue on the board. The rest of the discussion was tabled since the nominating committee chair was not present.

<u>Membership</u> (Tiffany): there are 4 new members pending. One of them (Aussie person) suggested trading mailing lists for premium lists. This was tabled.

#### Old Business:

<u>Insurance for board members</u>: Louise contacted Sportsman's and was quoted \$880. Leslie suggested Equisure for officers and board. The trailer is insured. The contents need updating.

Sacramento Council of Dog Clubs is still present (Pam).

<u>Taxes:</u> Tiffany reported that we are eligible for IRS e-postcard which has been filed and out 501-c status is intact. For state taxes, Tiffany has received 3 different answers regarding our non-profit status. A long story seemed to conclude that we need to prepare form to reinstate our non-profit status. Louise suggests getting a pro to sort the taxes out.

<u>Storage:</u> Tiffany discussed the cost of gravel to put under the trailer if it is stored at Jackie's. Louise will talk with Connie Batsford about short term storage of the trailer until we decide what to do with it and if she will accept a fee. The storage locker is costing us \$970 for six months. We will it for now.

#### **New Business:**

<u>Awards:</u> Louise will handle this in 2018 but suggests having the form in Ring Ropes. Kathy will send award forms out with membership renewals

<u>Christmas party:</u> We need a site. Dec. 12, 2018 is a Tuesday. We need a volunteer or restaurant. Firehouse Bistro in Dixon was suggested.

November meeting will be at the WOK of Flame in south Davis.

Tiffany wants people to think about community events we can offer or participate in.
